ABBREVIATED RULES:

The SEE'S CANDIES "MARY SEE'S BIRTHDAY SWEET-STAKES" ("Sweepstakes") starts at 12:01 a.m. Pacific Time ("PT") on 8/24/26 and ends at 11:59 p.m. (PT) on 9/19/26 ("Entry Period"). Open to legal residents of the 50 United States and DC who are 18 years of age or older with a valid email account as of the date of entry. Void in PR and where prohibited. 1. ELIGIBILITY: The "Mary See's Birthday Sweet-Stakes" (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older and have a valid email account as of the date of entry ("Eligible Entrants"). Employees of See's Candy Shops, Inc. ("Sponsor"), its parent, affiliates, subsidiaries, its Sweepstakes, advertising and internet agencies, including Administrator as defined below, and prize suppliers (and their respective employees, directors, officers and agents) (collectively, the "Released Parties"), and each member of their immediate family (spouse, parent, children and siblings and their respective spouses, regardless of where they reside) and/or those persons living in the same household, whether or not related, are not eligible to enter. TO ENTER THE SWEEPSTAKES BY MAIL: Eligible Entrants may enter the Sweepstakes by mail by hand printing your first and last name, street address (no post office boxes), city, state, zip code, daytime telephone number, date of birth and email address on a postcard only and mail the completed postcard entry to SEE'S CANDIES "MARY SEE'S BIRTHDAY SWEET-

ALL MAIL-IN ENTRIES MUST BE POSTMARKED BY 9/22/26 AND RECEIVED BY 9/26/26.

Online Entries and Mail-in Entries may be referred to herein as "Entry" and collectively as "Entries". Any individual submitting an Entry as detailed above shall be referred to herein individually as an "Entrant" and collectively as "Entrants". **LIMIT ONE (1) ENTRY PER PERSON/PER EMAIL ADDRESS/PER POSTCARD DURING THE ENTRY PERIOD REGARDLESS OF METHOD OF ENTRY. ENTRIES IN EXCESS OF THIS LIMIT WILL BE DISQUALIFIED.**

Proof of entering information on the Entry Site is not considered proof of delivery or receipt. Illegible, incomplete and duplicate Entries and Entries submitted by Entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified.

3.
