

**SEE'S CANDIES SWEEPSTAKES TO SEE "JUSTIN TIMBERLAKE | THE FORGET  
TOMORROW WORLD TOUR VIP TICKET GIVEAWAY"  
OFFICIAL RULES**

**IMPORTANT: PLEASE READ THESE OFFICIAL RULES BEFORE ENTERING THE SWEEPSTAKES.**

**NO PURCHASE OR NEWSLETTER SIGNUP IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR SIGNING UP FOR A NEWSLETTER WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

The SEE'S CANDIES "JUSTIN TIMBERLAKE | THE FORGET TOMORROW WORLD TOUR VIP TICKET GIVEAWAY" ("Sweepstakes") starts at 12:01 a.m. Pacific Time ("PT") on 10/25/24 and ends at 11:59 p.m. (PT) on 11/10/24 for online entry (may be referred to herein as the "Online Entry Period") and ends on 11/6/24 for the postmarking of a mail-in entry; with both methods as detailed below. The sponsor of this Sweepstakes is See's Candy Shops, Inc., 20600 S. Alameda Street, Carson, CA 90810 (the "Sponsor" or "See's Candies"). The Sweepstakes is subject to these Sweepstakes Official Rules (the "**Official Rules**"), and by entering, all participants agree to be bound by the terms and conditions herein.

**ELIGIBILITY: THE SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA, WHO ARE EIGHTEEN (18) YEARS OF AGE OR OLDER AS OF THEIR ENTRY DATE. THIS SWEEPSTAKES IS VOID IN PUERTO RICO, ALL U.S. TERRITORIES AND POSSESSIONS, OVERSEAS MILITARY INSTALLATIONS AND WHERE PROHIBITED OR RESTRICTED BY LAW.** Employees and their families (defined as parent, child, sibling and spouses) of the Sponsor their respective affiliates, subsidiaries, parent company(s) and advertising and promotion agencies (collectively, the "Promotion Parties") and those living in the household of same (whether related or not) are not eligible to enter or win. By entering this Sweepstakes, entrants agree to abide by all terms and conditions of these Official Rules. The laws of the United States apply to and govern this Sweepstakes and any claims must be raised and resolved in the federal or state courts located in the State of California, United States. All federal, state and local rules and regulations apply. A prize won by a minor (where the winner is at least 18 and a minor in the legal jurisdiction in which he or she resides) ("Minor") will be awarded in the name of said Minor's parent or legal guardian.

**HOW TO ENTER THE SWEEPSTAKES:** As detailed below, there are two (2) ways to enter the Sweepstakes; (1) online via the Entry Site (defined below) <OR> (2) by mail.

*TO ENTER THE SWEEPSTAKES ONLINE:* During the Online Entry Period, you may enter online by visiting the website at [www.sees.com/justin-timberlake-sees-contest](http://www.sees.com/justin-timberlake-sees-contest) (the "Entry Site"), opting in to the Sweepstakes and signing up for See's emails by providing your first and last name, address, zip code and email address and continuing the sign-up and entry process to its completion by clicking the checkbox verifying your age eligibility and following that, clicking on the "Submit" button to submit your completed entry ("Online Entry").

*To Enter By Mail:* To enter the Sweepstakes by mail without signing up for See's emails, hand print your first and last name, street address (no post office boxes), city, state, zip code, daytime telephone number, date of birth and email address (if applicable) on a postcard only and mail the completed postcard entry to SEE'S CANDIES "JUSTIN TIMBERLAKE | THE FORGET TOMORROW WORLD TOUR VIP TICKET GIVEAWAY", Attn: Consumer Affairs, 20600 S.

Alameda St. Carson, CA 90810 ("Mail-in Entry"). **ALL MAIL-IN ENTRIES MUST BE POSTMARKED BY 11/6/24 AND RECEIVED BY 11/11/24.**

Online Entries and Mail-in Entries may be referred to herein as an "Entry" and collectively as "Entries". Any individual submitting an Entry as detailed above shall be referred to herein individually as an "Entrant" and collectively as "Entrants".

**ONLY ONE (1) ENTRY WILL BE ACCEPTED PER INDIVIDUAL AND/OR EMAIL ADDRESS REGARDLESS OF METHOD(S) OF ENTRY. ENTRIES IN EXCESS OF THIS LIMIT WILL BE DISQUALIFIED.**

The Sponsor's clock shall be the official timekeeper for this Sweepstakes. For purposes of this Sweepstakes, an Online Entry is "received" when the Sponsor's server records the complete Online Entry information. Proof of entering information at the Entry Site or mailing an Entry (as detailed above) is not considered proof of delivery or receipt. Illegible, incomplete and duplicate Entries and Entries submitted by Entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified.

**WINNER SELECTION:** One (1) Grand prize winner, and two (2) Runner-Up winners will be selected in a random drawing from among all eligible Entries on or about 11/11/24 by representatives of the Sponsor, whose decisions are and shall be final and binding in all matters relating to this Sweepstakes.

The prize winners (or his/her parent or legal guardian if selected prize winner is a Minor) will be notified by email and/or telephone by 11/15/24. The Sponsor will confirm the concert location and date with Grand Prize and Runner Up Prize winners in writing. Once the concert date is confirmed by Sponsor, it cannot be changed. Winners may be required to execute and return a notarized Affidavit of Eligibility/ Release of Liability, and where legal, a Publicity Release form (collectively the "Documents") within seven (7) days of the date on the notification.

If a prize notification or prize is returned as undeliverable or is unable to be completed for any reason, the prize may, at Sponsor's sole discretion be awarded to an alternate in a subsequent random drawing. Prize is not transferable, assignable, or redeemable for cash. No substitution for the prize (or parts thereof) by the winner will be allowed. Due to the limited nature of the concert series, no changes or substitutions are allowed, even in the case of illness or weather, except as required by law.

All federal, national, state, and local tax liabilities, if any are the responsibility of the prize winner. Acceptance of the prize constitutes permission (except where prohibited) for the Sponsor and its designee(s) to use prize winner's name, likeness, biography, statements, voice, image and any other personal characteristics, in any and all media now or hereafter known, for any purpose, including without limitation marketing, promotional and publicity purposes without additional compensation to such individual or any limitation, and such individual hereby releases Sponsor and its designee(s) from any liability with respect to such use.

- 4 Round-Trip Airplane Tickets in Economy Class from one location to the concert location
- One (1) Night Hotel Stay the date of the Concert (Two Rooms Total)

**Retail value: \$5,700 total**

TWO (2) RUNNER UP PRIZES are available to be awarded: Each RUNNER UP prize consists of:

- 2 VIP Concert Tickets to one Justin Timberlake Concert, each Runner Up shall choose from **one** of the following dates and concert locations:
  - 12/6/2024 – Dallas, TX, American Airlines Center, or
  - 12/10/2024 – North Little Rock, AR, Simons Bank Arena, or
  - 12/12/2024 – Nashville, TN, Bridgestone Arena; or
  - 12/14/2024 – Pittsburgh, PA, PPG Paints Arena

**Retail value: \$1,300 total**

The odds of winning the prize are determined by the total number of eligible Entries received and are equal regardless of method of entry.

**GENERAL:** If for any reason this Sweepstakes is not capable of running as planned, or if this Sweepstakes or any website associated therewith (or any portion thereof) becomes corrupted or does not allow the proper playing of the Sweepstakes and processing of Entries in accordance with these rules, or if infection by computer virus, bugs, tampering, unauthorized intervention, actions by Entrants, fraud, technical failures, or any other causes, in the Sponsor’s sole opinion, corrupts or affects the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right, in Sponsor’s sole discretion, to disqualify any individual implicated in such action and/or to cancel, terminate, modify or suspend this

Sweepstakes or any portion thereof. In the event this Sweepstakes is cancelled, the Sponsor will conduct a random drawing to award the prizes from among all eligible, non-suspect Entries received prior to the time of the action or event warranting such cancellation. If such cancellation, termination, modification or suspension occurs, notification will be posted at the Entry Site. ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE ANY WEBSITE (INCLUDING THE ENTRY SITE) OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND/OR CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

If a dispute arises about who submitted an Entry on the Entry Site, the Entry will be deemed submitted by the authorized account holder of the email account entered. The authorized account holder of an email account entered is deemed the natural person who is assigned to an email address by an Internet access provider, service provider, or other online organization that is responsible for assigning email addresses for the domain associated with the submitted email address. A potential winner may be requested to provide Sponsor with proof that the potential winner is the authorized account holder of the email address associated with the potential winning Entry and that all eligibility requirements are met.

In the event a dispute regarding the identity of the individual who actually submitted an Entry cannot be resolved to Sponsor's satisfaction, the affected Entry will be deemed ineligible. The Releasees are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in Entrant's email account to receive email messages. Also, the Releasees are not responsible, and may disqualify an Entrant, if his or her email address does not work or if it is changed without Entrant giving prior written notice to Sponsor.

NOTE: Entry must be made by the Entrant only as detailed above.
